In order to qualify for the Warm Home Discount you are required to meet the following criteria:

### **In receipt of :-**

- Income related employment and support allowance (which includes a Work Related activity or Support component) or
- Income based Jobseekers' Allowance or
- Income Support or
- Universal Credit and not in work or self employed or earnings less than £1349 per month or
- Customer household has an annual income of less than £16,190

### **AND**

- Disabled child premium or disability or enhanced disability premium or
- Pensioner premium, higher pensioner premium or enhanced pensioner premium or
- Suffer from mental or physical disability or
- Receive disability benefits or registered disabled or
- Have a child aged under 5 who lives with you or
- Household fuel bills for heating more than 10% of gross annual household income or
- Require constant care or
- Rely on mains powered medical equipment

## EDF

In order to qualify for the Warm Home Discount you are required to meet the following criteria:

### **In receipt of :-**

- Income Based Job Seekers Allowance or
- Income Support or
- Income related Employment and Support Allowance or
- Universal Credit with earnings less than £1349 for at least one month since 1<sup>st</sup> October 2019 or
- Gross taxable annual household income of less than £16190 and pension credit or savings credit

## Eon

In order to qualify for the Warm Home Discount you are required to meet the following criteria:

**In receipt of :-**

- Savings credit or
- Born on or before 31<sup>st</sup> March 1955 and in receipt of Council Tax Reduction (single person's occupancy reduction is not eligible) or

**OR**

**In receipt of :-**

- Child tax credit and annual income of £16190 or less or
- Universal credit with child allowance and income of £1349 or less per month

**OR**

**In receipt of :-**

- Income related employment and support allowance or

**OR**

**In receipt of :-**

- Income support or Income base jobseekers allowance

**And in receipt of:-**

- Disability or pensioner premium
- Disabled child premium
- Child tax credit which includes a disability or severe disability element
- A child under 5 living with you
- Disability Living Allowance (DLA) or Personal Independence Payment (PIP)

**OR**

**In receipt of :-**

- Universal Credit with an income of less than £1349

**AND in receipt of:-**

- Disability Living Allowance (DLA) or Personal Independence Payment (PIP)
- Limited capability for work or work related element or
- Child element

**OR**

**In receipt of :-**

- Working tax credit with an annual income of less than £16190

**AND in receipt of:-**

- Disability Living Allowance (DLA) or Personal Independence Payment (PIP) or disability element

## Npower

In order to qualify for the Warm Home Discount you are required to meet the following criteria:

**In receipt of :-**

- Savings credit of pension credit OR
- Born on or before 31<sup>st</sup> March 1955 and in receipt of Council Tax Reduction for low income (25% single person reduction is not eligible)

OR

**In receipt of:-**

- Income related employment and support allowance

OR

**In receipt of:-**

- Child Tax Credit with a total household annual income of £16190 or less OR
- Universal Credit with child allowance and monthly income of £1349 or less

OR

**In receipt of:-**

- Income support or income based or job seekers allowance

**AND in receipt of:-**

- Disability or pensioner premium
- Disabled child premium
- Child tax credit which includes a disability or severe disability element
- A child under 5 living with you
- Disability Living Allowance (DLA) or Personal Independence Payment (PIP)

OR

**In receipt of:-**

- Working Tax credit with annual income of £16190 or less and Disability Living Allowance or Personal Independence Payment or disability element

OR

**In receipt of:-**

- Universal Credit with monthly earnings of £1349 or less

**AND in receipt of:-**

- Limited capability for work element or
- Disability Living Allowance (DLA) or Personal Independence Payment (PIP) or
- Child Element

## Scottish Hydro

In order to qualify for the Warm Home Discount you are required to meet the following criteria:

**In receipt of :-**

- Free school meals for children born on or before 1<sup>st</sup> April 2012

OR

**In receipt of:-**

- Income related employment and support allowance or
- Income based jobseekers allowance or
- Income related Employment and Support Allowance or

**AND In receipt of:-**

- War Disablement Pension or
- Incapacity Benefit or
- Disability Living Allowance/Personal Independent Payment adult or child or
- Have child born on or after 1<sup>st</sup> April 2015 or
- Pensioner premium or
- Disability premium adult or child or
- Severe Disablement Allowance or
- Child aged 18 years or under in full time education born on or after 1 April 2002 or
- Carers Allowance

OR

**In receipt of:-**

- Universal credit not in work or self employed or
- Universal credit with an earned income of less than £1349 in at least one month during the period 1<sup>st</sup> April 20 to 31<sup>st</sup> March 2021

**AND In receipt of:-**

- War Disablement Pension or
- Industrial Injuries Benefit or
- Disability Living Allowance/Personal Independent Payment or
- Have child born on or after 1<sup>st</sup> April 2015 or
- Pensioner premium or
- Disability premium adult or child or
- Severe Disablement Allowance

OR

**In receipt of:-**

- Incapacity Benefit or
- Contribution Based Employment and Support Allowance

**AND In receipt of:-**

- Council tax reduction (not including single occupancy discount) or
- Housing Benefit or
- Incapacity Benefit

OR

**In receipt of:-**

- Working Tax Credit and annual income of less than £16190

**AND In receipt of:-**

- Disability Living Allowance/Personal Independence Payment
- Disability Premium

## Scottish Power

In order to qualify for the Warm Home Discount you are required to meet the following criteria:

**In receipt of :-**

- Income Support or
- Income Related Employment and Support Allowance or
- Income Based Jobseeker's Allowance or
- Universal Credit and earned less than £1349 in one month in 12 preceding assessment periods or
- Total gross household income is less than £16,190

**AND**

- Disabled child premium, disability premium, severe disability premium or enhanced disability premium or Universal credit equivalent
- Receive Pensioner Premium, Higher Pensioner Premium or Enhanced Pensioner Premium
- Receive an income related Disability Living Allowance, Incapacity Benefit, Personal Independence Payments or Attendance Allowance or
- Be aged 65 or over or
- Have a child of 5 years or under or
- Have a child entitled to free school meals or
- Receive Child Tax Credit or Working Tax Credit which includes a disability element or severe disability element, disabled child element or severely disabled child element or family element or UC equivalent
- Have a child 18 years or under in full time education or
- Spends 10% or more of their household annual income on energy bills
- Receive limited capability for work or limited capability for work related activity in Universal Credit
